**A RESOLUTION ESTABLISHING FEES FOR THE FILING OF PERMITS UNDER
THE TOWNSHIP OF EAST ROCKHILL BUILDING INSPECTION SERVICES PROGRAM
ADOPTING THE THIRD PARTY FEE SCHEDULE DATED JANUARY 3, 2012
AND REPEALING ALL PRIOR FEE SCHEDULES.**

WHEREAS, the Board of Supervisors of East Rockhill Township has opted in to the Administration of the Pennsylvania Uniform Construction Code; and,

WHEREAS, East Rockhill Township employs a licensed and certified Building Code Official in conformance with the Pennsylvania Uniform Construction Code; and,

WHEREAS, it is the desire of the Board of Supervisors of the Township of East Rockhill to contract with neighboring municipalities to provide building inspection services; and,

WHEREAS, it is the desire of the Board of Supervisors of the Township of East Rockhill to charge sufficient fees to cover the cost of administering the Pennsylvania Uniform Construction Code,

NOW, THEREFORE BE IT RESOLVED by the Board of Supervisors of the Township of East Rockhill that all previous fee schedules are hereby repealed and that the 'East Rockhill Township Third Party Fee Schedule' dated January 3, 2012, a copy of which is attached hereto and incorporated herein by reference, is hereby adopted as the East Rockhill Township Third Party Fee Schedule.

 - 2. PLUS, \$.30 per square foot over 1,000 square feet
- B. Non-Residential
 - 1. First 1,000 square feet.....\$ 450.00
 - 2. PLUS, \$.35 per square foot over 1,000 square feet
- C. Mobile Homes & Modular with Cert\$ 150.00

II. ADDITIONS

Including attached garages, covered porches, covered patios and covered decks
