

**EAST ROCKHILL & HAYCOCK TOWNSHIP

NOTICE**

Sealed bids will be received, publicly opened, read aloud and considered by East Rockhill Township and Haycock Township on April 28, 2010 at 10:00 AM at the East Rockhill Township Office, 1622 N. Ridge Road, Perkasio, PA 18944 for consideration of Award at the Regularly advertised Board of Supervisors Meetings on May 3, 2010 at the Haycock Township Building, 640 Harrisburg School Road, Quakertown, PA 18951 and on May 11, 2010 at the East Rockhill Township Building, 1622 N. Ridge Road, Perkasio, PA 18944 for the fireproofing, painting and cosmetic restoration of the Sheard's Mill Covered Bridge. Haycock Township must also agree to the award of the contract as the project will be funded through a joint grant. The project is located on Covered Bridge Road (S.R. 4099), 1000-ft south of the intersection with West Thatcher Road in Haycock Township. The Bridge spans the Tohickon Creek and is located along the Township line between East Rockhill Township and Haycock Township.

Bids must be made on the forms furnished by East Rockhill Township and must be accompanied by a certified check or acceptable bid bond issued by a Surety licensed to conduct business in the Commonwealth of Pennsylvania, in the amount of at least ten percent (10%) of the total price bid made to East Rockhill Township. The successful Bidder will be required to furnish and pay for satisfactory Performance and Payment Bonds, each in the amount of one hundred percent (100%) of the Contract Price with a corporate surety approved by East Rockhill Township.

The Bidder's attention is called to the fact that the project is receiving funds under Title I of the Housing and Community Development Act of 1974. The successful Bidder must ensure that employees and applicants for employment are not discriminated against because of race, color, religion, sex or national origin. The Bidder's attention is also called to the fact that the project is subject to the Davis Bacon Act. The Bidder's attention is further called to the fact that this project will be funded through a grant administered by Bucks County and the payment for the work will be subject to the same. East Rockhill Township and Haycock Township are grantees of the grant and both municipalities will need to approve the awarding of the bid and the subject agreement. East Rockhill Township is the lead municipality for the project.

If a Contract is awarded, it will be to the lowest responsible bidder. However,

East Rockhill Township and Haycock Township expressly reserve the right to reject or accept any or all bids and may re-advertise if the best interests of East Rockhill Township and Haycock Township are to be hereby promoted. East Rockhill Township and Haycock Township may waive technical defects if, in their judgment, the best interests of East Rockhill Township and Haycock Township shall so require. No bid may be considered from any person, firm or corporation who has defaulted in the performance of any contract or agreement previously made with East Rockhill Township and/or Haycock Township or conclusively shown to have failed to perform satisfactorily such contract or agreement with East Rockhill Township and/or Haycock Township.
