Approval of Minutes from April 24, 2019 Regular Meeting

Chief's Report: Chief Blake

Chief Blake read the monthly report indicating Department activities for the month of May, 2019.

On motion by Mr. Keyser, seconded by Mr. Volovnik, to approve the Chief's Report as presented. With no additional discussion, all present voted in favor.

Mr. Keyser advised that he recently saw a 53 foot Fed Ex truck on Allentown Road. The road is to be posted excluding truck traffic. A discussion was had regarding the posting of signage by Pa Dot.

Chief Blake presented a note of thanks to Officer Kolb and himself for assistance with an incident in West Rockhill.

Chief Blake advised that he is renewing the service contract from Air Management Technologies for the HVAC unit. The cost of the 1 year contract is \$3600.

Chief Blake then advised that the PD would again be partnering with the Red Cross for the annual blood drive at the station. The date of the blood drive is July 18, 2019 2pm to 7pm. Chief Blake mentioned that the Rockhill Car Wash would donate a car wash coupon to those who donated blood.
