43	11/10/1975	Approving form of agreement providing for transportation of sanitary sewage and industrial wastes collected by the Township's sanitary sewage collection system and authorizing execution of agreement.
Res. 83-5	7/11/1983	Resolving that the proposed second amendment to agreement to reserve sewer connections executed on or about June 30, 1983, by Michael J. Cappello shall be duly signed and sealed by the Board of Supervisors on behalf of East Rockhill Township.
Res. 84-2	2/21/1984	Permitting Thomas and Betts Corporation to connect its manufacturing plant at Part Avenue and Ridge Road into the East Rockhill Township public sewer system.
Res. 85-7	11/19/1985	Entitling the Thomas and Betts, Ansley Division, industrial facility located on Park Avenue to connect to the public sewer system of the Township conditioned upon payment of a sewer connection fee.
Res. 86-2	1/21/1986	Resolving that, until further resolution of the Board of Supervisors, no additional sewer reservation agreements shall be entered into by the Township. Sewer connections shall be made available to property owners and developers to the extent that the capacity is available at the time that actual connection is desired.
Res. 86-3	1/21/1986	Authorizing the Chairman of the Board of Supervisors to approve and sign the Act 339 application presently being prepared by the Township Engineer to establish the Township's eligibility for certain funds for sanitary sewer improvements.
Res. 86-4A	5/27/1986	Proposing that the Moyer Subdivision (Hill Rd.) be served by the East Rockhill Township sewage systems.

Res. 88-1	2/16/1988	Proposing that the Grouse Greine Subdivision be served by the public sewage systems.
Res. 90-18	11/20/1990	Authorizing the assessment and collection of charges for each lot on Meadow Lane abutting the public sewer system and benefitted thereby.
Res. 93-12	5/18/1993	Proposing that the Chadd's Place Subdivision be served by and sewer extension.
Res. 96-4	1/16/1996	Proposing that the Fenley Tract Subdivision be served by sewer extension.
Res. 96-15	-/-/1996	Requiring East Rockhill Township to adopt an official sewage facilities plan for the provision of adequate sewage systems and to revise said plan from time to time as may be necessary.

Res. 98-15	8/11/1998	Authorizing contemplated construction of an extension to the Township's existing sanitary sewer line from the intersection of Old Bethlehem Pike and Three Mile Run Road in the Township south to the Perkasio Borough line.
Res. 98-18	9/8/1998	Proposing that Cruz Bay Properties, Fenley Tract-Parcel III (Phase IV), be served by a sewer extension.
Res. 98-23	12/14/1998	Authorizing the assessment and collection of charges for each lot abutting the public sewer line in the vicinity of Old Bethlehem Pike and Ridge Road within the Township.
