## Municipal Office Addition & Renovation

Consider issuing formal notice to all prime contractors notice to proceed date set four weeks from the lifting of applicable Governor's COVID-19 Orders

Within days of the Township staff's preconstruction meeting with contractors held on March 16, 2020, the Governor issued business shutdown orders related to COVID-19. At the March meeting a date was set for construction to commence May 4, 2020. Due to unknown duration of the Governors orders, that date is no longer practical, and as such, a formal Notice to Proceed was not issued. Subsequent to the shutdown order, General Contractor (GC) issued a notice of potential delay claim to preserve their rights.

In the meantime, Township staff have been in contact with the contractors, who are working with limited staff. They have been able to prepare many of the required submittals, which have been processed by the Township and reviewed by the Architect. Staff has requested color samples for final selections. This process will continue thru the shutdown.

Township Engineer has reviewed anticipated construction schedule with the General Contractor (GC) for when the applicable shutdown order is lifted. GC advised they can commence construction of this project within 3 to 4 weeks of the permitted restart of construction projects. All other prime contractors have been advised of this timeline. To date, no objections have been received.

Contract specifications allow for a 12-month construction period which commences on the notice to proceed date. As the notice was not formally issued, the construction clock has not started. Township Engineer recommends that the Supervisors review the anticipated construction schedule as discussed above, and if satisfactory, the Township should issue a letter to all prime contractors advising of East Rockhill Township's intent to issue a formal notice to proceed date set four weeks from the lifting of applicable Governors orders. The 12-month construction period clock will then start from that date. Effective per 4/6/2020 Email from Greg Lippincott:

## I. <u>BACKGRO UND</u>

On February17, 2020, Dan Scholl (the "*Applicant*") filed a conditional use application for property located at 2301 N. Fifth Street in East Rockhill Township requesting approval to construct a Car Washing facility (the "*Application*"). The Board of Supervisors of East Rockhill Township held a public hearing on the Application on March 24, 2020. Applicant's engineer, K2 Consulting Engineers submitted documents in support of the application along with a sworn affidavit. The solicitor for the Board of Supervisors, John B. Rice, Esquire was present at the hearing. A stenographic record of the hearing was taken remotely by Veritext Legal Solutions because of the statewide COVID-19 statewide disaster declaration. The March 24, 2017 hearing was advertised in the March 10, 2020 and March 17, 2020 editions of The Intelligencer.

Pursuant to the Pennsylvania Municipalities Planning Code and Section 27-2207 of the East Rockhill Township Zoning Ordinance, the Board of Supervisors of East Rockhill Township held a public hearing on the Application. Supervisors David Nyman, Gary Volovnik and James Nietupski were in attendance.

## II. FINDINGS OF FACT

1. The subject property is located at 2301 N. Fifth St., East Rockhill Township, Pennsylvania and further described as Bucks County Tax Map Parcel No. 12-015-001 ("Property"). The record owner of the Property is Jean Scholl, 250 Route 313, Perkasie, Pa. 18944.

2. The Property consists of 6.6 acres, is located in the Village Commercial (VC) Zoning District, and is served by onsite wells and onsite sewage disposal.

3. The Applicant is requesting approval to construct as 3,812 sq,ft. car wash facility on the Property containing two car bays and one truck bay.

**NOT APPROVED** 

4. The Property currently contains four buildings with multiple uses, all to remain.

5. The Applicant has concurrently filed a land development plan which requires approval before proceeding with the construction of the car wash facility.

6. The project will require a Penn DOT highway occupancy permit (HOP).

7. The Township Planning Commission recommended approval of the Application on March 12, 2020 subject to the submission of additional information regarding water usage and traffic generation.

## III. <u>CONCLUSIONS OF LAW</u>

1. Sections 27-1001 and 27-1003 of the Township Zoning Ordinance require conditional use approval for a car wash in the VC Zoning District (F-25 Use) and conditional use approval where there are multiple uses on a lot in the VC District.

2. Applicant has met the requirements for conditional uses set forth in Section 27-2208 of the Township Zoning Ordinance.

## <u>O R D E R</u>

**AND NOW**, this \_\_\_\_\_\_ day of April, 2020, after due deliberation and discussion, the East Rockhill Township Board of Supervisors does hereby approve Applicant's conditional use application subject to the following conditions of approval, each of which the Board of Supervisors deems a necessary and essential component of this approval:

- 1. Compliance with the Township's SLDO unless modified by the Board of Supervisors.
- 2. Compliance with PennDOT requirements regarding ingress and egress to the site.
- 3. Compliance with Township and County requirements with respect to on lot sewer service.
