Approval of Minutes from April 22, 2020 Regular Meeting

The capital reserve account funds total \$150,183.42. It should be noted that the department was requiring only 1 authorized signature on the checks issued by the department instead of the normal 2 signature requirement. This was approved by QNB and was requested due to COVID-19 restrictions.

On motion by Mr. Volovnik, seconded by Mr. Collingwood, to approve payment of Bills List dated May 27, 2020 totaling \$45,971.75 and the Financial Report as presented. With no additional discussion, all present voted in favor.

Chief's Report: Chief Blake

Chief Blake read the monthly report indicating Department activities for the month of April, 2020.

On motion by Mr. Volovnik, seconded by Mr. Collingwood, to approve the Chief's Report as presented. With no additional discussion, all present voted in favor.

Solicitors Report: John Rice, Esq.

Mr. Rice gave the Board an update on the HVAC litigation. He advised the Board there will be a date in the future for mediation and that there will be a conference call with the Board to discuss the mediation process.
