Consideration in hiring full time officer: Chief Dickinson requested permission to move forward with the hiring of Michael Klein, to replace the vacancy of Sgt. Maloney.

Chief Dickinson made an announcement to the Commission that he had received word that the department had been awarded a \$648,408 grant from the PA Commission on Crime and Delinquency. The Chief explained that the funding was obtained to upgrade the current Records Management System and also install stationary License Plate Readers (LPR) at seven intersections located in East and West Rockhill Township.
