Third Draft of 2024 Preliminary Budget:

Chief Dickinson reviewed his September 22, 2023 memorandum for recommended items in the 2024 preliminary budget. Mr. Keyser expressed the proposed camera upgrade expense of \$50,000.00 in account 409.740 Building Capital Purchase and proposed West Rockhill American Rescue Funds or Capital Reserve Fund revenue of \$43,000.00 in account 399.145 Balance Forward be removed because it should be West Rockhill Township board decision to make the allocation and they have not determined use of the American Rescue Funds at this time. Mr. Schirmer agreed with Mr. Keyser to remove the allocation in Balance Forward. Mr. Keyser recommended the budget be approved with the removal of these two items and a stipulation that before advertising to add a new Officer to the Department in June 2024 a motion be required from the commission.

On motion by Mr. Keyser, seconded by Mr. Volovnik, to approve the 2024 budget as presented contingent on removing \$50,000.00 camera upgrade from line item 409.740; removing \$43,000.00 West Rockhill American Rescue Fund or Capital Reserve allocation from line item 399.145 and require commission authorization to advertise prior to adding an Officer to the department in June 2024. With no additional discussion, all present voted in favor.

2024 Minimum Municipal Obligation:

Chief Dickinson presented the 2024 Minimum Municipal Obligation (MMO) for the Uniformed and Administrative pension plans.

On motion by Mr. Keyser, seconded by Mr. Volovnik, to acknowledge the 2024 Minimum Municipal Obligation as presented. With no additional discussion, all present voted in favor.

Engagement with Eckert Seamans:

On motion by Mr. Schirmer, seconded by Mr. Volovnik to execute the engagement letter from Eckert Seamans for Labor Law purposes as presented. With no additional discussion, all present voted in favor.

DCED Grand Funding for Equipment Purchases:

Chief Dickinson requested approval by the board to move forward with applying for Pennsylvania Department of Community & Economic Development for equipment replacement.

On motion, by Mr. Keyser, seconded by Mr. Schirmer to authorize Chief Dickinson to move forward with application for the DCED grant program as presented. With no additional discussion, all present voted in favor.

Citizen Comment #2:

 Mr. Nyman stated the need for a motion to formally recognize the 2024 MMO presented earlier in the meeting. At that request a motion was made, indicated above.
