Fifth Street, Perkasie, East Rockhill Township, also known as Tax Map Parcel Number 12-014-004. This property is located in the C-E Cultural-Education Zoning District. The property currently contains the Renew Bible Church, which was formerly known as First Baptist Church of Perkasie. The Applicant is proposing to expand the main building and the hillside building by constructing additions totaling 10,364 square feet. **On motion** by Mr. Chlebda, seconded by Ms. McAnally, to grant the applicant approval for a variance from Section 27-304.C.C1.c and/or Section 2103.a to add 172 parking spaces and from Section 27-1102.b to permit an impervious surface percentage of 32.41% where 30% is the maximum allowed, conditioned on apply for and obtain land development approval; comply with Stormwater Management Ordinance and obtain a National Pollutant Discharge Elimination System permit from the Pennsylvania Department of Environmental Protection; install parking lot lighting so it is shielded and directed downward; reduce parking lot lighting per exhibits introduced; utilize and maintain pervious paving per submitted plan; install an evergreen buffer to the satisfaction of the Township Engineer between Hawthorne property and sheds located on the northeastern side of the Applicant's Property; turn off general parking lot lights, except for security lighting, at 10:30 p.m. except for special events; and compliance with all testimony and exhibits. With no additional discussion, all present voted in favor.

Executed Findings of Fact, Conclusions of Law and Decision will be the Official Decision of the Zoning Hearing Board.
