Final Adoption of the 2024 to 2028 Police Contract

Chief Dickinson, along with the Public Safety Commission, presented a final draft of the 2024 to 2028 Police Contract to the Commission for approval and signatures.

Discussion regarding the in-house camera server replacement/improvements

Chief Dickinson presented a memorandum outlining the needs for a replacement server after the current server failed early on in the month. Additionally, Chief Dickinson presented options for improvements to the system that would allow for better security and safety of prisoners, officers and visitors. Included in the memorandum was explanation of a budget surplus that would allow the upgrades to occur with no financial impact on the 2024 budget.

On motion by Mr. Keyser, seconded by Mr. Volovnik, to authorize the Chief to proceed with station camera upgrades, specifically with the Keystone Fire and Security proposal, in the amount of \$51,565.95 as presented. With no additional discussion, all present voted in favor.
