Park & Recreation Rules & Regulations Summary:

- ✓ The undersigned is familiar with Township Park Rules in Code of Ordinance §16-103.
- ✓ Park hours are sunrise to sunset.
- ✓ **Following are Prohibited:**
 - Alcoholic beverages and smoking including cigarettes, cigars, pipes, chewing Tabaco, vaping, etc.
 - Vendors or special entertainment are not permitted except by special permit issued by the Township.
 - Open fires, fireworks, and grills.
 - Do not attach decorations by nails, tacks, or staples on pavilion poles, picnic tables,

etc. Permit holder is responsible for the removal of all decorations, trash and recycling from the park generated from the event as a courtesy to following groups. If the park was left in unsatisfactory condition upon your arrival, notify the Township immediately by voice mail or email to ensure the security deposit is returned.

- Moon bounces and other inflatable devices.
- Use of amplified music.
- Parking in spots designated for golf driving range patrons or grass areas. Additional parking is available in the rear of Willard H. Markey Centennial Park.
- ✓ Permit holder is required to have the approved permit with them when using a park facility where such a permit is required.
- ✓ Animals must be kept on a leash.
- ✓ East Rockhill Township shall not be held responsible for any injury sustained by any individual during the course of recreational activities taking place.
- ✓ A security deposit is required by a separate check. To have the check returned, a self-addressed stamped envelope (SASE) must accompany this application. If a SASE is not received the check will be destroyed upon completion of the activity(s) and adherence to the rules and regulations. The liability for damage incurred by the Applicant is not limited to the amount of this deposit fund.
- ✓ Approved park use permits are issued via electronic mail to the responsible party.

Security Deposit Refundable if:

- No littered trash and/or food around grounds reserved.
- No damage to structure (including stapling / tacking of posters or signs), furnishings and fields.
- User leaves the premises in as good or better condition than which existed prior to their usage.
- User has followed all the Park Rules & Regulations.
- All equipment has been returned in good order.
- The deposit is to be returned at the discretion of the East Rockhill Township Manager.
